

**The WePlay Animajor Winner Prediction OFFICIAL RULES.  
No Purchase Necessary To Participate Or Win.  
Void Where Prohibited.**

**Sponsor:** The WePlay Animajor Champion Prediction (the "Game") is sponsored by Gosu Media (Europe) Limited, [52, St Christopher Street, Valletta, Malta](#) VLT 1462 (the "Sponsor").

**Description:** The WePlay Animajor Champion Prediction ("Game") is devised as a non-gambling promotion and is intended solely for entertainment purposes. "Entrant" (as defined below) is required to predict the results of the The WePlay Animajor Champion for year 2021 and each Entrant is allowed to make one (1) prediction. A point will be awarded to an Entrant for each correct prediction in the Game. Prizes will be awarded to the Entrants who have predicted correctly at the end of the Game as detailed below. Each Entrant shall strictly be entitled to one (1) entry and any multiple entries made by the Entrant by any means whatsoever shall automatically disqualify the said Entrant for the Game.

**Eligibility:** The Game is open to all who are eighteen (18) years and above (PROVIDED THAT if the age of eighteen (18) years shall not be the minimum age of majority for the Entrant's respective state/province/territory of residence then the Entrant is required to strictly abide by the legislation governing the same), (hereinafter referred to as "Entrant"). **To Participate:**

- (1) To participate, during the Game Period visit [www.GosuGamers.net](http://www.GosuGamers.net) ("the Website") and click on the banners, buttons and/or links to access the Game registration page. Participation is free. To participate, complete and submit the Game Registration form according to the instructions provided. As part of the registration process, you will be asked if you wish to receive promotional emails from the GosuGamers and your agreement to the same shall solely be based on your own volition and discretion. Such Agreement is not a pre-requisite for you to sign up or participate in this Game, and shall not in any manner whatsoever affect the chances of your winning. All information and details provided by the Entrants must be current, accurate and authentic. Each Entrant shall be entitled and restricted to one (1) registration. Any multiple registration by the Entrants by any means whatsoever shall automatically be nullified and deemed as void and the Entrant will be automatically disqualified. The use of script, macro or any other device to automate or subvert the registration process is prohibited and all such registrations will be void. For clarification an accurate prediction shall mean any prediction made correctly by the Entrant in selecting the champion for The WePlay Animajor.

The winner of the Game shall be determined and selected at the end of the Game based on the first ten (10) Entrants.

- (a) to have submitted the correct prediction of the champion for the grand final of the WePlay Animajor based on the records of the Sponsor; If ten (10) winners could not be determined based on the manner provided in the preceding paragraph (a), a raffle and random draw will be carried out and only ten (10) grand winners will be selected and entitled for the prizes (“Grand Winner”).
